**ORDER GRANTING RECEIVER'S EMERGENCY MOTION FOR AUTHORITY TO
(I) ENTER INTO THE SERVICES AGREEMENT AND THE STAFFING AGREEMENT
AND (II) WIND DOWN THE OAKLAND OPERATIONS**

This matter coming to be heard on the *Receiver's Emergency Motion for Authority to Enter Into (I) the Services Agreement With Freightwave Transport LLC and (II) the Temporary Staffing Agreement With Carson Consulting Corp. in Connection With the Wind Down of the Oakland Operations* [Dkt. No. 49] (the "Motion");¹ the Court having determined that granting the relief requested in the Motion is in the best interests of the receivership estate; this Court having jurisdiction over this action and personal jurisdiction over the Defendants and their property that is the subject of the Motion; it appearing that under the circumstances of this case due and proper notice of the Motion having been given and no other or further notice is necessary:

IT IS HEREBY ORDERED:

1. The Motion establishes sufficient grounds for the relief requested and therefore, the Motion is granted as set forth herein.
2. The Receiver is authorized to wind down the Oakland Operations.
3. The Receiver is authorized to enter into the Services Agreement with Freightwave Logistics LLC, a copy of which is attached to the Motion as Exhibit A and incorporated herein by this reference.
4. The Receiver is authorized to enter into the Staffing Agreement with Carson Consulting Corp., a copy of which is attached to the Motion as Exhibit B and incorporated herein by this reference. For the purposes of clarity, all Temporary Staffing provided by Carson Consulting under the Staffing Agreement shall be members of Teamsters Local 70.

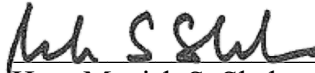
¹ Capitalized terms not defined herein shall have the meanings ascribed to them in the Motion.

5. The Receiver is authorized to take any and all actions as may be necessary or appropriate to wind down the Oakland Operations and implement the terms and provisions of the Services Agreement and the Staffing Agreement.

6. The Court retains exclusive jurisdiction with respect to all matters arising from this Order.
